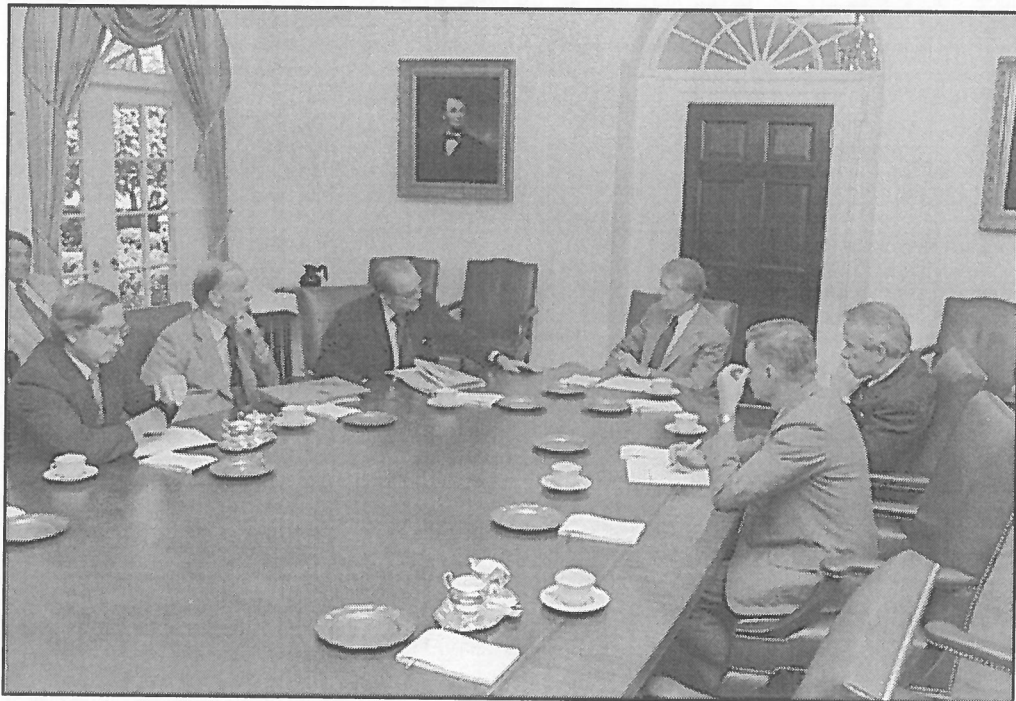

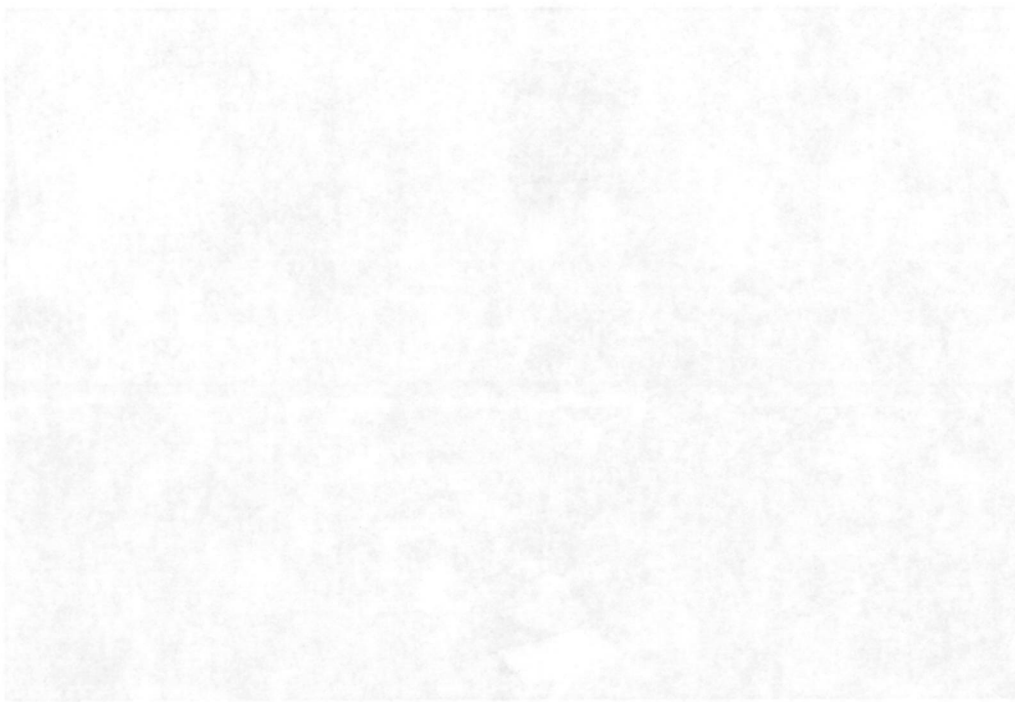

INTRODUCTION

“...I want to speak to you today about the strands that connect our actions overseas with our essential character as a nation. I believe we can have a foreign policy that is democratic, that is based on fundamental values, and that uses power and influence, which we have, for humane purposes. We can also have a foreign policy that the American people both support and, for a change, know about and understand...we know that democracy works; we can reject the arguments of those rulers who deny human rights to their people. We are confident that democracy's example will be compelling...and we are confident of the good sense of American people, and so we let them share in the process of making foreign policy decisions. We can thus speak with the voices of 215 million, and not just of an isolated handful...” Jimmy Carter,

Jimmy Carter aspired to make Government "competent and compassionate," responsive to the American people and their expectations. His achievements were notable, but in an era of rising energy costs, mounting inflation, and continuing international tensions, it was impossible for his administration to meet these high expectations.

President Carter believed in the rule of law in international affairs and in the principle of self-determination for all people. Moreover, he wanted the United States to take the lead in promoting universal human rights. Carter believed that American power should be exercised sparingly and that the United States should avoid military interventions as much as possible. Finally, he hoped that American relations with the Soviet Union would continue to improve and that the two nations could come to economic and arms control agreements that would relax Cold War tensions.

This new collection provides unique, and never published, documents on the major international issues confronting the Carter administration, including: Middle East Peace and the Camp David Accords; NATO and the Rapid Deployment Force; Human Rights; relations with the People's Republic of China; Panama Canal Treaty; Strategic Arms Limitation Talks (SALT II); covert intervention in Afghanistan following the Soviet invasion; and the Iran Hostage Crisis.

Documents include: presidential correspondence and memoranda with his cabinet, Executive branch departments and agencies, prominent public figures, and foreign heads of state; cables and telegrams, between American foreign missions and the State Department; briefing books for international conferences; and texts of treaties and international law.

Jimmy Carter, the Presidency, and Foreign Affairs

Military Cutbacks in South Korea

During his first month in office President Carter cut the defense budget by \$6 billion. One of his first acts was to order the unilateral removal of all nuclear weapons from South Korea and announce his intention to cut back the number of U.S. troops stationed there. Other military men confined intense criticism of the withdrawal to private conversations or testimony before congressional committees, but in 1977 Major General John K. Singlaub, chief of staff of U.S. forces in South Korea, publicly criticized President Carter's decision to lower the U.S. troop level there. On March 21, 1977, Carter relieved him of duty, saying his publicly stated sentiments were "inconsistent with announced national security

policy". Carter planned to remove all but 14,000 U.S. air force personnel and logistics specialists by 1982, but after cutting only 3,600 troops, he was forced to abandon the effort in 1978.

Arab-Israeli Conflict/Camp David Accords

Carter's Secretary of State Cyrus Vance and National Security Adviser Zbigniew Brzezinski paid close attention to the Arab-Israeli conflict. Diplomatic communications between Israel and Egypt increased significantly after the Yom Kippur War and the Carter administration felt that the time was right for comprehensive solution to the conflict.

One of Carter's most important accomplishments as President was the Camp David Accords on September 17, 1978. They were a peace agreement between Israel and Egypt negotiated by President Carter, which followed up on earlier negotiations conducted in the Middle East. In these negotiations King Hassan II of Morocco acted as a negotiator between Arab interests and Israel, and Nicolae Ceaușescu of Romania acted as go-between for Israel and the Palestinian Liberation Organization (PLO, the unofficial representative of the Palestinian people). Once initial negotiations had been completed, Egyptian President Anwar Sadat approached Carter for assistance. Carter then invited Israeli Prime Minister Menachem Begin and Sadat to Camp David to continue the negotiations. The Camp David Accords produced two frameworks for peace between Egypt and Israel, and a peace treaty was later signed on March 26, 1979.

Rapid Deployment Forces

On October 1, 1979, President Carter announced before a television audience the existence of the Rapid Deployment Forces (RDF), a mobile fighting force capable of responding to worldwide trouble spots, without drawing on forces committed to the North Atlantic Treaty Organization (NATO). The RDF was the forerunner of CENTCOM.

Human Rights

President Carter initially departed from the long-held policy of containment toward the Soviet Union. In its place Carter promoted a foreign policy that put human rights at the front. This was a break from the policies of several predecessors, in which human rights abuses were often overlooked if they were committed by a nation that was allied with the United States. The Carter Administration ended support to the historically U.S.-backed Somoza regime in Nicaragua and gave aid to the new Sandinista National Liberation Front government that assumed power after Somoza's overthrow. However, Carter ignored a plea from El Salvador's Archbishop Óscar Romero not to send military aid to that country. Romero was later assassinated for his criticism of El Salvador's violation of human rights.

Carter continued his predecessors' policies of imposing sanctions on Rhodesia, and, after Bishop Abel Muzorewa was elected Prime Minister, protested the exclusion of Robert Mugabe and Joshua Nkomo from participating in the elections. Strong pressure from the United States and the United Kingdom prompted new elections in what was then called Zimbabwe Rhodesia (now Zimbabwe), which saw Robert Mugabe elected as Prime Minister of Zimbabwe; afterwards, sanctions were lifted, and diplomatic recognition was granted. Carter was also known for his criticism of Paraguay's Alfredo Stroessner, Augusto Pinochet (who was forced to grant Chile a constitution providing for a transition back into democracy), the Apartheid government of South Africa, Zaire (although Carter later changed course and supported Zaire, in response to alleged - albeit unproven - Cuban support of anti-Mobutu rebels and other traditional allies).

People's Republic of China

Carter continued the policy of Richard Nixon to normalize relations with the People's Republic of China by granting them full diplomatic and trade relations, and not with Taiwan (though the two nations continued to trade and the U.S. unofficially recognized Taiwan through the Taiwan Relations Act). In the Joint Communiqué on the Establishment of Diplomatic Relations dated January 1, 1979, the United States transferred diplomatic recognition from Taipei to Beijing. The U.S. reiterated the Shanghai Communiqué's acknowledgment of the Chinese position that there is only one China and that Taiwan is a part of China; Beijing acknowledged that the American people would continue to carry on commercial, cultural, and other unofficial contacts with the people of Taiwan.

Panama Canal Treaties

One of the most controversial moves of President Carter's presidency was the final negotiation and signature of the Panama Canal Treaties in September 1977. Those treaties, which essentially would transfer control of the American-built Panama Canal to the nation of Panama, were bitterly opposed by a majority of the American public and by the Republican Party. A common argument against the treaties was that the United States was transferring an American asset of great strategic value to an unstable and corrupt country led by a military dictator (Omar Torrijos). Those that supported the Treaties argued that the Canal was built within Panamanian territory therefore, by controlling it, the United States was in fact occupying part of another country and this agreement was intended to turn back to Panama the sovereignty of its complete territory. After the signature of the Canal treaties, in June 1978, Jimmy Carter visited Panama with his wife and twelve U.S. Senators, amid widespread student disturbances against the Torrijos dictatorship. Carter then began urging the Torrijos regime to soften its policies and move Panama towards gradual republicanism.

Strategic Arms Limitations Talks (SALT)

A key foreign policy issue Carter worked laboriously on was the SALT II Treaty, which reduced the number of nuclear arms produced and/or maintained by both the United States and the Soviet Union. The work of Gerald Ford and Richard Nixon brought about the SALT I treaty, which had itself reduced the number of nuclear arms produced, but Carter wished to further this reduction. It was his main goal (as was stated in his Inaugural Address) that nuclear weaponry be completely eradicated from the face of the Earth. Carter and Soviet General Secretary Leonid Brezhnev, reached an agreement to this end in 1979 — the SALT II Treaty, despite opposition in Congress to ratifying it, as many thought it weakened U.S. defenses. Following the Soviet invasion of Afghanistan late in 1979 however, Carter withdrew the treaty from consideration by Congress and the treaty was never ratified (though it was signed by both Carter and Brezhnev). Even so, both sides honored the commitments laid out in the negotiations.

Intervention in Afghanistan

The United States secretly began sending aid to anti-Soviet, Afghan Islamist factions on July 3, 1979. In December 1979 the USSR invaded Afghanistan, after the pro-Moscow Afghanistan government, put in power by a 1978 coup, was overthrown. At the time some believed the Soviets were attempting to expand their borders southward in order to gain a foothold in the region. The Soviet Union had long lacked a warm water port, and their movement south seemed to position them for further expansion toward Pakistan in the East, and Iran to the West. American politicians, Republicans and Democrats alike, ignorant of U.S. involvement, feared the Soviets were positioning themselves for a takeover of Middle Eastern oil. Others believed that the Soviet Union was afraid Iran's Islamic Revolution and Afghanistan's Islamization would spread to the millions of Muslims in the USSR.

After the invasion, Carter announced what became known as the “Carter Doctrine” -- that the U.S. would not allow any other outside force to gain control of the Persian Gulf. He terminated the Russian Wheat Deal, which was intended to establish trade with USSR and lessen Cold War tensions. The grain exports had been beneficial to people employed in agriculture, and the Carter embargo marked the beginning of hardship for American farmers. He also prohibited Americans from participating in the 1980 Summer Olympics in Moscow, and reinstated registration for the draft for young males.

Carter and Brzezinski started a \$40 billion covert program of training Islamic fundamentalists in Pakistan and Afghanistan as a part of the efforts to foil the Soviets’ apparent plans. On the surface as well, Carter's diplomatic policies towards Pakistan in particular changed drastically. The administration had cut off financial aid to the country in early 1979 when religious fundamentalists, encouraged by the prevailing Islamist military dictatorship over Pakistan, burnt down a U.S. Embassy based there. The international stake in Pakistan, however, had greatly increased with the Soviet invasion of Afghanistan. The then-President of Pakistan, General Muhammad Zia-ul-Haq, was offered 400 million dollars to subsidize the anti-communist Mujahedeen in Afghanistan by Carter. General Zia declined the offer as insufficient; famously declaring it to be “peanuts”; and the U.S. was forced to step up aid to Pakistan.

Reagan would later expand this program greatly to combat Cold War concerns presented by Russia at the time. In retrospect, this contributed to the collapse of the Soviet Union. Critics of this policy blame Carter and Reagan for the resulting instability of post-Soviet Afghan governments, which led to the rise of Islamic theocracy in the region, and many of the current problems with Islamic fundamentalism.

Iran Hostage Crisis

The main conflict between human rights and U.S. interests came in Carter's dealings with the Shah of Iran. The Shah, Mohammad Reza Pahlavi, had been a strong ally of America since World War II and was one of the “twin pillars” upon which U.S. strategic policy in the Middle East was built. On a state visit to Iran, Carter spoke out in favor of the Shah, calling him a leader of supreme wisdom, and a pillar of stability in the volatile Middle East.

When the Iranian Revolution broke out in Iran, and the Shah was overthrown, the U.S. did not intervene. The Shah went into permanent exile. Carter initially refused him entry to the United States, even on grounds of medical emergency. Despite his initial refusal to admit the Shah into the United States, on October 22, 1979, Carter finally granted him entry and temporary asylum for the duration of his cancer treatment; the Shah left for Panama on December 15, 1979. In response to the Shah's entry into the U.S., Iranian militants seized the American embassy in Tehran, taking 52 Americans hostage. The Iranians demanded: the return of the Shah to Iran for trial; the return of the Shah's wealth to the Iranian people; and, an admission of guilt by the United States for its past actions in Iran, plus an apology, and a promise from the United States not to interfere in Iran's affairs in the future. Though later that year the Shah left the U.S. and died in Egypt, the hostage crisis continued and dominated the last year of Carter's presidency. The subsequent responses to the crisis—from a "Rose Garden strategy" of staying inside the White House, to the unsuccessful attempt to rescue the hostages by military means—were largely seen as contributing to Carter's defeat in the 1980 election.

After the hostages were taken, President Carter issued, on November 14, 1979, Executive Order 12170 - Blocking Iranian Government Property, which was used to freeze the bank accounts of the Iranian government in U.S. banks, totaling about \$8 billion at the time. This was to be used as a bargaining chip for the release of the hostages.

In the days before President Ronald Reagan took office, Algerian diplomat Abdulkarim Ghuraib opened fruitful, but demeaning, negotiations between the U.S. and Iran. This resulted in the "Algiers Accords" one day before the end of the Carter's Presidency on January 19, 1981, which entailed Iran's commitment to free the hostages immediately. Additionally, Executive Orders 12277 through 12285 were issued by Carter releasing all assets belonging to the Iranian government and all assets belonging to the Shah found within the United States and the guarantee that the hostages would have no legal claim against the Iranian government that would be heard in U.S. courts. Iran, however, also agreed to place \$1 billion of the frozen assets in an escrow account and both Iran and the United States agreed to the creation of a tribunal to adjudicate claims by U.S. nationals against Iran for compensation for property lost by them or contracts breached by Iran. The tribunal, known as the Iran-United States Claims Tribunal, awarded over \$2 billion dollars to U.S. claimants and has been described as one of the most effective arbitration bodies in the history of international law. Although the release of the hostages was negotiated and secured under the Carter administration, the hostages were released on January 20, 1981 moments after Ronald Reagan was sworn in as President.

SOURCE AND CONTENT NOTE

The White House Central Files (WHCF) was a reference system shared by the President and his staff. It included many of their communications with each other, federal agencies, Members of Congress, and individuals and institutions across the spectrum of American public and private life. In addition, foreign government correspondence was included as well.

The Subject File of the White House Central Files contained correspondence and reports pertaining to the functions and operations of the White House; the federal government; and state, local, and foreign governments. In addition, the Subject File contained correspondence and reports from private companies, organizations, and individuals. It also included copies of outgoing correspondence and memoranda, as well as other documents that were acted on or brought to the attention of the President or a designated key White House official.

According to the White House Central Files manual, the FO (Foreign Affairs) category was for “material pertaining to international relations or in connection with the plans, policies, procedures and programs, regarding foreign countries or governments ... (including) matters relating to the administration of foreign affairs; economic development; mutual security; and foreign information and exchange activities.”

The FO subject category was subdivided into a number of sub-categories in an effort to facilitate filing and retrieval of documents. These sub-categories are described below.

FO: Foreign Affairs

Materials on various foreign affairs matters, notably comments, inquiries and studies from congressmen, public affairs groups, and the general public.

FO 1: Buildings - Grounds

Materials on U.S. Foreign Service facilities in foreign capitals

FO 2: Diplomatic - Consular Relations

Material on Ambassadorial appointments, especially monthly status reports to the President on vacancies, incumbencies and tour expirations; and material on such matters concerning the U.S. diplomatic corps as selection standards, protection, autographed presidential photographs, commendations, etc.

FO 2/A: Diplomatic - Consular Relations/Appointments

Foreign Service appointment and promotion lists, and related transmittal memoranda and authorization requests.

FO 2/CO#: Diplomatic - Consular Relations/(Country)

Material on the appointment and activities of U.S. ambassadors including: biographical data; White House staff concurrences to proposed nominees; some presidential meeting proposals and briefing material; and miscellanea on aid, conduct of individuals, and diverse other matters. Arranged by country file code

FO 2/CO#/A: Diplomatic - Consular Relations/(Country)/Appointments

Material on the nomination, commission and resignation of U.S. ambassadors. Primarily routine items such as clearance notices, nomination document signature requests, and biographical data released to the press; but also including some resignation letters, briefing material and other items. Arranged by country file code.

FO 2-1: Personal or Special Rank of Ambassador or Minister

Material on the nomination or accreditation of special U.S. ambassadors, ministers or representatives. Primarily routine memoranda.

FO 3: Economic - Technical Development

Material on economic development matters.

FO 3-1: International Waterways

Material, notably correspondence between the White House, state and local officials, Congressmen, and industry groups, on: off-shore fishing rights and boundaries; fishing rights; waterway regulations and similar matters.

FO 3-1/A-Z: International Waterways/(Name of Waterway)

FO 3-1/Fisheries: International Waterways/Fisheries

Material on international fishing disputes and jurisdictional problems, especially 200 mile off-shore limit claims.

FO 3-1/Panama Canal: International Waterways/Panama Canal

Material on Canal Company regulations and especially Canal treaty negotiations with Panama, notably Congressional support or opposition thereto.

FO 3-2: Mutual Security

Material on U.S. military and economic foreign aid programs and legislation, including the PL 480 program, Military Assistance Program (MAP), arms export controls, and Agency for International Development programs.

FO 3-2/CO: Mutual Security/(Country)

Material on specific foreign military and economic aid programs.

FO 3-2-1: Alliance for Progress

FO 4: Financial Relations

Material on various aid and monetary matters.

FO 4-1: Balance of Payments

Material on international financial developments, including material on import valuation methods for computing the merchandise trade balance and items on various matters effecting balance of payments.

FO 4-2: Loans-Funds

Material on U.S. lending agencies and aid programs, and U.S. participation in international lending agencies. Among the subjects are: Export-Import Bank legislation, loan credits, foreign debt settlement, and loan agreements.

FO 4-3: International Investments

Material on U.S. investment overseas and foreign investment in the U.S.

FO 5: Information - Exchange Activities

Material on governmental and non-governmental information and exchange programs, studies, proposals, and requests.

FO 5-1: Information - Exchange Activities - Educational

Material on various governmental and non-governmental educational exchange programs, proposals and organizations. Among these are expressions from participating students and information on youth organizations, the American Field Service, and US-Soviet exchange programs.

FO 5-2: Scientific - Cultural - Business Exchange Activities

Reports, proposals, comments and messages on exchange activities conducted under the auspices of the U.S. government, private groups and foreign nations.

FO 5-3: Publicity International

Materials on the President's relations with the foreign press, especially interview requests and related items, with summaries of foreign press coverage.

FO 5-3-1: Foreign Publications

Material, primarily cross-references, on foreign publications, acknowledgment of their receipt, message and interview requests from them, and related matters.

FO 6: International Conferences

Material on U.S. participation in various international conferences.

FO 7: International Law

Material, primarily cross-references, on various negotiations or points of international law, especially Law of the Sea.

FO 8: Foreign Travel

Primarily material on routine notifications, clearances and itineraries, but sometime includes draft messages, cable traffic, briefing material and reports on trips. Travel by the President is not included.

FO 8-1: Letters of Introduction

Requests by private organizations, citizens, and state officials for letters of introduction to foreign officials and overseas U.S. diplomatic officials, and related material.

FO 8-2: Passports - Visas

Material on passport problems, legislation and design changes; and visa problems of various individuals and groups.

FO 9: Treaties

Primarily materials on transmittal messages to Congress, text of treaties, conventions, protocols and agreements; and on legislation concerning congressional review of executive agreements.
