# INTRODUCTION

The events and personalities of John F. Kennedy's one thousand days in office reflect the complex nature of the character and decision-making processes of the Kennedy presidency. Issues addressed by the Kennedy administration included the "realpolitik" of the Cold War (i.e., Berlin Crisis, 1961; Geneva Conference on Laos; and the nuclear test ban) and the growing domestic unrest over civil rights, housing, and states rights. These issues elicited views sharply disparate from various segments of the American public and from within the government itself. This oral history is particularly well suited for the investigation and evaluation of these issues and views as they affected the Kennedy presidency. The flexibility of the oral history technique lends itself readily to the recording of multiple viewpoints because the interviewee is free to backtrack and embellish topics whenever the flow of ideas calls associated insights to mind. Moreover, the oral history encourages the interviewee to be an active participant in the reconstruction of past events, so that he or she can suggest a fertile line of enquiry that even a well-prepared interviewer might have failed to anticipate. Finally, the oral history is a natural vehicle for the candid exposition of personal perspectives on the part of those who knew and served under John F. Kennedy. These personal perspectives are indispensable to a thorough understanding of the Kennedy presidency and the Kennedy era as a whole.

The firsthand recollections that are reproduced in this microform publication reveal, in a readily accessible form, fresh perspectives on John F. Kennedy the man, on John F. Kennedy the president, and on the speakers themselves. Most importantly, these oral histories recapture the experiences and impressions of those who served during the eventful one thousand days of the Kennedy presidency—many in key policy-making positions. For nearly every major event in Kennedy's presidency (and 1960 campaign), the oral histories contain candid recollections, many of which have not appeared in contemporaneous documents. Within the two installments of *The John F. Kennedy Presidential Oral History Collection*, published by UPA, the researcher will find commentary on the major issues confronting the New Frontier and the Kennedy era. Oral histories such as these, whether consulted alone or in conjunction with the official documentation of the era, provide scholars with an especially rich source.

# SCOPE AND CONTENT NOTE

In 1964, the John F. Kennedy Library Project undertook an oral history program to record and preserve the recollections of prominent and private individuals, both in and out of the Kennedy administration. These oral recollections were not meant to be memorials to John F. Kennedy, but rather a contribution to the understanding of the Kennedy era.

*Part I* of UPA's microform publication, *The John F. Kennedy Presidential Oral History Collection*, consists of interviews with people from various executive departments. The interviewees relate their particular insights, analyses, and evaluations of the various issues and crises confronting American foreign and domestic policies in the early 1960s.

Within *Part I*, the researcher interested in interviewees intimate with the various foreign policy crises will find oral histories from: Arthur Schlesinger, Jr., special assistant to the president; Roger Hilsman, director, Bureau of Intelligence and Research, State Department, and assistant secretary of state for Far Eastern affairs; W. Averell Harriman, undersecretary of state for political affairs; and Walt Rostow, chairman, Policy Planning Council, State Department.

Also found in *Part I* are interviews with key domestic policymakers and managers during the Kennedy era. The researcher interested in interviewees with intimate details on the planning and implementation of President Kennedy's New Freedom programs will find: Anthony Celebrezze, secretary of Health, Education, and Welfare; Myer Feldman, deputy special counsel to the president; Berl Bernhard, staff director, Civil Rights Commission; George McGovern, director, Food for Peace; and Burke Marshall, assistant attorney general, Civil Rights Division, Justice Department.

In order to provide the researcher with a comprehensive view of the Kennedy administration, there are also interviews with many government and public personalities who, although not household names, still played key roles or participated in important events during the Kennedy era: General Lucius Clay, the president's personal representative in Berlin, 1961; Leonard Mayo, chairman, President's Panel on Mental Retardation; and Roger Stevens, special assistant to the president on the arts. Additionally, *Part I* contains panel-type interviews. Members of the panels, selected and interviewed by staff of the John F. Kennedy Oral History Program, represent the combined views of various mid- and upper-level government officials from the Council of Economic Advisers, Immigration and Naturalization Service, various regulatory agencies, and the Cuban Prisoner Exchange Program.

*Part II* of *The John F. Kennedy Presidential Oral History Collection* contains interviews with such diverse personalities as congressmen and senators, Supreme Court justices, political functionaries, labor leaders, civil rights leaders, foreign dignitaries, and family friends. These interviews provide the researcher with various perspectives of the Kennedy era, both public and private.

Within *Part II*, the researcher interested in analyses and assessments of the legislative process and judiciary system during the Kennedy administration will find oral histories from: J. William Fulbright, senator from Arkansas and chairman of the Senate Foreign Relations Committee; John McCormack, representative from Massachusetts, Speaker of the House; Mike Mansfield, senator from Montana and Senate majority leader; Albert Gore, senator from Tennessee; and Emanuel Celler, representative from New York. An analysis and evaluation of the judiciary and the judiciary's response to the growing social movements and interpretations of law can be gleaned from the oral histories of Justice Felix Frankfurter, Judge Thurgood Marshall, and Justice William O. Douglas.

*Part II* also contains oral histories from various state officials and party functionaries. The views of these interviewees present a firsthand account of the growth of the political career of John F. Kennedy, as well as extensive coverage of the 1960 presidential campaign. The interviewees also

address various social issues and programs such as civil rights, urban renewal and rural development, and states rights vs. federal rights. The interviewees include: John Amos from West Virginia, member of the Democratic National Committee; Ross Barnett, governor of Mississippi; Abraham Beame, mayor of New York; Michael DiSalle, governor of Ohio; Jackson J. Holtz, vice chairman, John F. Kennedy's 1960 senate campaign; and J. Leonard Reinsch, executive director, Democratic National Convention in 1960 and 1964.

In addition to the oral histories of congressional and political figures, *Part II* includes oral histories by social, labor, media, and international personalities. These include: Clarence Mitchell, director, Washington Bureau, NAACP; James Farmer, national director, Congress of Racial Equality; Richard Cardinal Cushing, Roman Catholic archbishop of Boston; Joseph Rauh, vice chairman, District of Columbia Democratic Committee; Gilbert Harrison, editor and publisher, *New Republic*; and Robert Nathan, chairman, National Executive Committee, Americans for Democratic Action. Oral histories of international leaders include: Sir Alec Douglas-Home, prime minister of Great Britain; Norodom Sihanouk, head of state, Cambodia; Nikita Khrushchev, premier of the Soviet Union; Ahmed Sukarno, head of state, Indonesia; and Juan Bosch, president, Dominican Republic.

Also included in *Part II* are transcripts of two panel discussions relating to President Kennedy and his administration. For the first, the John F. Kennedy Oral History Program co-sponsored the Brandeis University Conference on Poverty and Urban Policy in June 1973. The purpose of the conference was to better understand the origins and development of the federal "poverty programs" in place during the Kennedy and Johnson administrations. The recollections and opinions of the participants provide the researcher with a deeper understanding of the federal social welfare ideas of the 1960s. The second panel discussion, the Press Panel, involved various leading press personalities and concentrated on the issue of President John F. Kennedy's relationship with and use of the press.

Interviews from the Robert F. Kennedy Oral History Program have been integrated into this microform publication. These oral histories represent a firsthand account of Bobby Kennedy's influence as presidential adviser and brother. The interviewees recount their experiences with and assessments of Robert F. Kennedy as U.S. attorney general, senator, and 1968 presidential candidate.

The oral histories highlighted above represent only a fraction of the collection. In their entirety, these oral histories provide a public, as well as private, view and evaluation of the personalities, policies, and events that influenced the Kennedy era.

## EDITORIAL NOTE

The John F. Kennedy Library in Boston, Massachusetts, contains millions of pages of documentation about John F. Kennedy and his times, including the largest collection of oral histories concerning Kennedy's presidency and political career. There are over one thousand interviews in this collection, entitled *The John F. Kennedy Presidential Oral History Collection*. However, due to privacy and other restrictions, not all of these were available for this publication.

Because of the number and variety of persons interviewed, University Publications of America (UPA) has grouped the interviews included in this publication by vocation and published them in two installments, each available from UPA in both microfilm and microfiche formats. The first installment, entitled *Part I: The White House and Executive Departments*, contains oral histories of key officials and aides from almost every sector of the executive branch under President Kennedy. The second installment, entitled *Part II: The Congress, the Judiciary, Public Figures, and Private Individuals*, includes oral histories of members of the House of Representatives and Senate, Supreme Court justices and members of the federal and state judiciary; labor, religious, business, and civil rights leaders; members of the legal community and the media; and many others, including longtime personal friends of the Kennedys.

UPA has published in their entirety all of the "open" or nonrestricted oral history transcripts, and some that have been "closed" or restricted by the interviewee. Permission was and continues to be sought by UPA to publish the closed oral histories. Those for which permission is received will be included in a future supplemental publication. UPA has included in this publication the forward attached to each oral history transcript by the John F. Kennedy Library. This forward stipulates the copyright and/or other restrictive covenants that may govern further publication of a particular oral history transcript.

A combined alphabetical list of the interviewees in *Part I* and *Part II* is included at the end of this guide. This list will direct the researcher to the respective page in the Fiche/Reel Index on which each individual's interview(s) is detailed.

# FICHE/REEL INDEX

The following index is a guide to both the microfiche and microfilm editions of Part I and Part II of *The John F. Kennedy Presidential Oral History Collection*. Each part is arranged alphabetically by the interviewees' last names. The numbers appearing in parentheses to the right of an interviewee's name identify the location, within the collection, of an oral history for that person. The first set of numbers indicates the oral history's location in the *microfiche* edition. The fiche number is sometimes followed by a part number (some oral histories that are very long, have more than one interviewer, or have been conducted on more than one date are divided into parts). Numbers to the right of the slash indicate the oral history's location in the *microfilm* edition. First is the reel number, followed by a colon and the four-digit frame number at which the oral history begins.

Next the researcher will find the position or positions held by an interviewee under John or Robert Kennedy, plus the years that the interviewee held the position or positions. In cases where years are not identified, the notation "n.d.," or "no date," appears following the applicable position. (*Note:* Some years overlap into other administrations.) Following are the interviewer's name; his or her position, where applicable; the project with which he or she was associated; the date of the interview; and the page count.

Extra material such as correspondence or newspaper articles is included with some oral histories. This material is detailed preceding the page count and its pages are included in the page count. Text in brackets indicates whether portions of an interview are unavailable or missing. Included with some oral histories in the microform portion of this publication is a forward stipulating any applicable restrictions on the material, such as copyrights or other limitations on access.

Most of the oral histories are from the John F. Kennedy Library; other sources include the Lyndon Baines Johnson Library, the Robert F. Kennedy Oral History Project, and independent contributors. See the Editorial Note on page ix for a further description of this collection.
